To be a member of FIBCA we require the following:

- The company applying for membership must be involved in the FIBC / bulk bag industry as a manufacturer or a vendor of bulk bags (regular member), or as a supplier to the industry (associate member).
 - Regular Members are FIBC manufacturers, distributors and importers.
 - Associate Members / Suppliers to the industry (manufacturers of fabric, webbing, equipment, etc. or providers of any industry related service).

Important Note! Your company can become a member of FIBCA regardless of where your company is located. FIBCA is a global association representing the FIBC / Bulk Bag Industry.

- The applicant must have at least \$1,000,000.00 (one million USD) in liability insurance. Liability insurance provides protection from claims arising from product related injuries or damage to people or property
- A one time initiation fee of \$500 USD is due on approval of the membership application and annual FIBCA membership dues of \$2500 USD are due each February 1st.
